The search and rescue team consists of approximately 50 highly motivated volunteers, both adult and Explorer Scouts, and is managed by a Sworn Sheriff's Sergeant and Deputy within the Helicopter/SAR Unit. The volunteers have varying degrees of first aid training and search and rescue skills. The SAR team is used for lost person and evidence searches. The SAR team also responds to searches outside of Sonoma County when a mutual aid request is made through the State Office of Emergency Services.

BECOMING A SEARCH AND RESCUE MEMBER

Membership is available to all citizens of Sonoma County who are at least 21 years of age. The applicant must be in good physical and mental condition. Search and Rescue volunteers are members of the Sheriff's Department and therefore may not have a felony conviction, and must be free of misdemeanor convictions during the last three years. A background investigation and physical examination is performed on each candidate prior to employment. Once accepted, the volunteer must complete an extensive training program before he/she is allowed to participate in a search.

EXPLORER SEARCH AND RESCUE

Membership for those under 21 years old is available through the Explorer Search and Rescue post. Qualification is male or female, ages 14 through 21 years old. They must maintain a 2.0 grade point in school and achieve a certificate in First Responder medical training. NOTE: Members must attend a majority of the search call-outs; certificate for First Responder within first year of membership and attend 50% of the training offered each month during the year.

Volunteer in Policing

The Sonoma County Sheriff's Department's Volunteers in Policing (V.I.P.) program was established to better connect with the community we serve. It is the latest chapter in a long history of utilizing volunteers to augment the paid law enforcement, detention and support staff, following other successful volunteer programs including Search and Rescue, Reserve Deputies and Explorer Scouts.

V.I.P. members contribute greatly to our organization through the donation of their time. Their contributions in the field as well as in the office enables our Deputies and Support Staff to better respond to calls for service and generally meet our responsibilities to the public.

The V.I.P. unit is designed to assist Department personnel with duties not specifically defined as law enforcement activities. V.I.P. members are not used to displace or replace paid staff, only to augment and extend services provided by staff or add an additional service.

The V.I.P. unit is composed of unpaid, volunteer, adult citizens from Sonoma County. After receiving general and task-specific training, V.I.P.s are utilized as additional "eyes and ears" of the Department and to perform a variety of specialized assignments under the supervision of Department staff.

Applicants are required to possess a valid drivers license at the appropriate level including necessary special endorsements, as required by the state of California to perform the essential job functions of this position. Candidates for this position will be required to pass a background investigation.

Volunteer Explorer Scout

WHAT IS THE EXPLORER PROGRAM?

The Sonoma County Sheriff's Department Explorer Post is a group of young men and women interested in careers in law enforcement. Explorers get a combination of classroom trainings and hands on experience that teaches them about the rigorous and challenging field of law enforcement.

Exploring is a program sponsored by both the Sheriff's Department and the Boy Scouts of America Learning for Life Program. It is open to young men and women between the ages of 15 and 21, who have completed the 8th grade. Sheriff's Explorers usually meet in the evenings on the first and third Tuesday of each month. Meetings are held at the Sheriff's Department (located at 2796 Ventura Avenue in Santa Rosa) and at off site locations.

OPPORTUNITIES OFFERED

Explorers receive instruction in the following areas:

- * Laws of Arrest
- * Arrest Techniques
- * Defensive Tactics
- * Firearms
- * Crime Scene Management
- * Fingerprinting
- * Traffic Control
- * Using Two-Way Radios
- * Report Writing

Explorers are required to attend all regularly scheduled meetings and serve an additional four hours each month for community service duties. This may include assisting in Sheriff Department sponsored activities, community events and parades. Additionally, Explorers participate in the Department's ride-along program.

Explorers take part in local and regional trainings and competitions with other explorer posts. Each Explorer is expected to attend a one time, eight day Explorer Academy located at the local law enforcement training center.
